1)	<i>I</i> ,	_, understand that state law requires construction to
	be done by a licensed contractor and have	e applied for an owner-builder permit under an
	exception from the law. The exemption s	pecifies that I, as the owner of the property listed
	may act as my own contractor with certai	n restrictions even though I do not have a license.

- 2) I understand that building permits are not required to be signed by a property owner unless he or she is responsible for the construction and *is not* hiring a licensed contractor to assume responsibility.
- 3) I understand that, as an owner-builder, I am the responsible party of record on a permit. I also understand that I may protect myself from potential financial risk by hiring a licensed contractor and have the permit filed in his or her name instead of my own name. I also understand that a contractor is *required by law* to be licensed in Florida and to list his or her license numbers on permits and contracts.
- 4) I understand that, as the owner-builder, I must provide direct, onsite supervision of the construction.
- 5) I understand that *I may not hire* an unlicensed person to act as my contractor or to supervise persons working on my building or residence. It is my responsibility to ensure that the persons whom I employ have licenses required by law and by Town Ordinance.
- 6) I understand that it is frequent practices of unlicensed persons to have the property owner obtain an owner-builder permit that erroneously implies that the property owner is providing his or her own labor and materials. *I*, as an owner-builder may be held liable and subjected to *serious* financial risk for any injuries sustained by an unlicensed person or his or her employees while working on my property. My homeowner's insurance may not provide coverages for these injuries. I am willfully acting as an owner-builder and am aware of the limits of my insurance coverage for injuries to workers on my property.
- 7) I understand that I may not delegate the responsibility for supervising work to a licensed contractor who is not licensed to perform the work being done. _____(Initials)
- 8) I agree that as the party *legally and financially* responsible for this proposed construction activity, I will abide by all applicable laws and requirements that govern owner-builders as well as employers. I also understand that the construction must comply with all applicable laws, ordinances, building codes, and zoning regulations.
